## Who has to take the IRS Competency Test?

Individuals who want to prepare federal income tax returns (Form 1040 series) for compensation and/or represent clients before the IRS must pass the Registered Tax Return Preparer Competency Test.

#### The following individuals will be exempt from testing:

- Attorneys, Certified Public Accountants, and Enrolled Agents who are active and in good standing
  with their licensing agency have no additional requirements other than to renew their PTIN
  annually.
- Supervised Preparers and Non-1040 Prepares are exempt from the Competency Exam requirement.

## When do I have to take the IRS RTRP Competency Test?

Tax preparers with a provisional PTIN will have until December 31, 2013 to pass the competency test. Tax preparers can continue to prepare all types of tax returns and claims for refund through 12/31/13, provided they complete any required continuing education requirements and renew their PTIN on time each year.

#### **How do I register for the IRS Competency Test?**

You must have a PTIN in order to schedule a test. You will be asked for the file number when scheduling your test. The file number is provided on your PTIN Welcome or Renewal Letter.

## What languages will the competency test be available in?

Currently, the test is only offered in English.

#### How can I locate a testing center?

Those required to take the test will need to physically go to a testing site, authenticate their identity, and take the test in person at the testing site. Click here to view a complete list of testing centers.

### What is the fee to take the IRS RTRP Competency Test?

The test is \$116 and must be paid at the time the appointment is scheduled. The test fee is non-refundable and not transferrable. Refer to the <u>Candidate Information Bulletin</u> to read the policy for rescheduling appointments.

## **How long is the IRS Competency Test?**

There are 120 questions. The test is timed at 2 ½ hours and your appointment will average 3 hours. You should plan to arrive for your test appointment at least thirty minutes early to check in. Once you are seated in the test room, you will receive a personalized introduction to the testing system.

## Will the IRS RTRP Competency Test be open book or resource assisted?

Certain resources will be provided at the testing center, including a calculator, Form 1040, Form 1040 instructions and Publication 17. You should view the <u>test tutorial</u> to better understand how to use these sources electronically on test day.

#### What should I bring to the IRS Competency Test?

- One un-expired U.S. government issued photo ID that includes your name, photo, and signature.
- Paper and pencil, a calculator, and reference materials will be provided at the test site.
- Personal items are not allowed in the test room and must be stored in a locker.
- Persons not scheduled to take a test are not permitted to wait in the test center.

## **How is the IRS RTRP Competency Test Scored?**

Test questions are weighted in value to arrive at an overall pass/fail score. If you fail the test, you will receive diagnostic information to assist you with future examination preparation. More information about test results can be found in the Candidate Information Bulletin.

#### How will I know if I passed the IRS Competency Test?

Candidates taking the test before late February 2012 will receive their test results in the mail within 60 days of the date they tested. After late February 2012, candidates will receive their test results immediately upon completion of the test.

#### Do I need to report my scores to the IRS?

No. The scores will automatically be shared with the IRS and IRS records will be updated accordingly. If you have an online PTIN account, the test information will be updated on the "Next Steps" page in your account in 7-10 business days.
